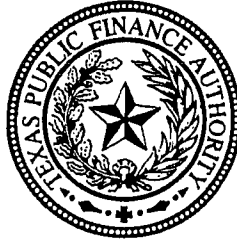

***Reconvene Open Meeting***


**Item 4.** The open meeting will be reconvened for Board action concerning matters deliberated in the Closed Meeting, if such action is required.
