## MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE TEXAS PUBLIC FINANCE AUTHORITY June 8, 2005

The Board of Directors (the "Board") of the Texas Public Finance Authority (the "Authority") convened in open meeting, notice duly posted pursuant to law (a copy of which notice is attached hereto as Exhibit "A") at 11:00 A.M., Wednesday, June 8, 2005, Capitol Extension Hearing Room E2.010, Austin, Texas. Present were: Mr. David Kelly, Chairman; Mr. Bert Mijares, Vice President; Mr. Marcellus Taylor, Member; Mr. Vaughn Brock, Member; and Ms. Ruth Schiermeyer, Member.

Representing the Authority's staff were: Ms. Kimberly Edwards, Executive Director, Mr. John Hernandez, Deputy Director, Ms. Judith Porras, General Counsel, Ms. Pamela Scivicque and Ms. Paula Hatfield.

### **Item 1. Call to order.**

Mr. Kelly called the meeting to order at 11:07 A.M.

### **Item 2. Approval of minutes of the May 9, 2005 Board meeting.**

Mr. Kelly asked if there were any corrections or additions to the minutes of the Board meeting of May 9. Mr. Mijares moved to approve the minutes. Ms. Schiermeyer seconded. The motion passed unanimously.

**Item 3. Select winning bid and adopt a resolution authorizing the issuance of approximately \$17,500,000 Texas Public Finance Authority Stephen F. Austin State University Revenue Financing System Revenue Bonds, Series 2005, the execution of documents in connection therewith, and other related actions to effect the sale and delivery of the bonds and resolve related matters.**

Ms. Edwards explained that bids for the \$17,500,000 Texas Public Finance Authority Stephen F. Austin State University Revenue Financing System Revenue Bonds, Series 2005, were received at 10 a.m. through Parity electronic bidding system, which allows underwriters to submit bids through an Internet website. No bids were submitted via hand delivery. The bids were verified by the Authority's financial advisers, Trey Cash and Mary Williams, First Southwest Co. The compliant bids were: Merrill Lynch & Co. 4.123616%; J. P. Morgan Securities Inc. 4.135270%; ABN AMRO Financial Services, Inc. 4.144528%; UBS Financial Services, Inc. 4.145511%; First Albany Capital Inc. 4.156918%; A. G. Edwards & Sons, Inc. 4.163750%; Banc of America Securities, LLC, 4.186074; and Piper Jaffray 4.221601%. Mr. Mijares moved to accept the lowest bid, awarding the bonds to Merrill Lynch & Co. and approve the Resolution. Mr. Brock seconded. The motion passed unanimously.

**Item 4. Legislative Update.**

Ms. Edwards reviewed a number of bills passed by the 79th Legislative Session.

**Item 5. Other Business/Staff Report**

Ms. Edwards stated that the July board meeting will likely be a work session for new and current board members.

**Item 6. Adjourn.**
